



Deposit Bonus Promotion

Terms and Conditions

Introduction

1. These Terms and Conditions (“Terms”) form the basis of the “Credit bonus” promotional offer, whereby Eligible Clients of ECM may be rewarded with a credit bonus to live accounts (“Offer”) when trading FX and CFDs on these accounts, subject to these Terms.
2. Taking part in this Offer constitutes acceptance of these Terms. ECM reserves the right to alter, amend or terminate this Offer, or any aspect of it, at any time and without prior notice. We may make changes to these Offer Terms and will notify you of these changes by posting the modified Terms on the ECM website. We recommend that you revisit these Terms regularly and, by your continued use of the ECM website and services you accept any such modified Terms.
3. We reserve the right, at our sole discretion, to disqualify any individual that tampers or attempts to tamper with the operation of the Offer, or breaches the Offer Terms or our Terms and Conditions of Business.
4. Any dispute or situation not covered by these Offer Terms will be resolved by our management in a manner it deems to be the fairest to all concerned. That decision shall be final and/or binding on all entrants. No correspondence will be entered into.
5. If these Offer Terms are translated into a language other than English, then the English version of the Terms shall prevail where there is an inconsistency.

Conditions of Eligibility

6. Subject to all other Terms, the Offer is available to Customers who have satisfied the Eligibility Criteria for the Offer (“Eligible Client”) as set out in clause 7 below.
7. The Eligibility Criteria for the Offer are:
 - (a) that it shall only apply to ECM Customers that have funded into a live account (this includes existing account holders and new Customers that open accounts);
 - (b) the live account will be a MT4 trading account;
 - (c) that the Customer makes a new deposit into their account/s after opting-in to the Offer;
 - (d) that the Customer must trade a set number of FX / CFD standard lot round turn transactions over the “Lots Calculation Period” on the account/s into which a deposit has been made. At the end of the promotional period the reward will be forfeited if the requisite number of standard lot round turn transactions has not been made. For the avoidance of doubt, any trades in other instruments will not count towards the lots calculation for this Offer.

Further Conditions

8. Eligible Clients cannot withdraw funds from any accounts during the promotional period or ALL the credit bonus will be forfeited. Transfers between accounts will count as withdrawal. Transfers between accounts will not count as new deposits or be included in the total net deposit value for the purposes of this Offer.
9. The transfer of rewards between accounts is not permitted during the Promotional Period.
10. Account holder can do **conversion of Credit Bonus to Account Balance for every USD150 bonus on an account**, Eligible Clients must trade a minimum of **60 standard lots** round turn transactions over the Lots Calculation Period on that account. **To convert the bonus, send a email to info@ecmtrader.com** with subject ‘Request on Conversion of Credit Bonus’. It will be converted to balance upon approval.
11. **Open position will be closed when cash equity of the account reached zero.**
12. The changes of ‘credit bonus’ will be added or removed from the account/s, may affect the equity and margin level on your open positions, possibly closing some or all of your positions. This will be done automatically by our Risk Management System that limits your potential losses.

The Offer

14. Subject to all other Terms, any credit bonuses due to an Eligible Client will be credited on the date of deposit:

Bonus Type	Net Deposit Value (USD)	Credit Bonus	Round Turn Requirements to convert Credit as Balance
Welcome Bonus First Time Deposit of NEW ECM Account Holder	100 onwards	20% bonus (Each account can hold maximum USD3,000 credit bonus)	60 Standard Lots for every USD150 bonus
Loyalty Bonus Subsequent Deposit of CURRENT ECM Account Holder	100 onwards	10% bonus (Each account can hold maximum USD3,000 credit bonus)	

Definition of 'Period'

15. The Promotional Period consists of the following:

- (a) The Deposit Bonus is only **valid till next working day** upon the date of authorize person signed.

Risk Warning

16. It is important that Eligible Clients are aware that their risks are not limited to the deposit and that by making a qualifying trade it is possible to lose more than the deposit. In some circumstances, losses may be considerably more than any initial or minimum deposit.
